### **Notice Regarding Prior Criminal Activity Including Drug usage**

To be considered for employment as a firefighter, applicants or undetected criminal activity. However, applicants on the ears clear of any detected soft drug usage on an experimental basis within READ ONLY considered:

- Illegal Soft drugs a warijuana, hashish, hash oil (prior to the date of legalization, October 17, 2018), edible cannabis extracts, cannabis topicals (prior to the date of legalization, Oct. 17, 2019) and mushrooms.

Any involvement in unlawful activity beyond the three years prior to your date of application will be assessed on an individual basis.

You are expected to remain free from criminal activity while in the Firefighter Pre-Screening process.

### **Personal History Statement and Truth Verification Process**

**Honesty, Integrity** and **Ethics** are scrutinized closely in considering firefighter applications. The PHS and truth verification process are used to assist in determining an applicant's suitability for employment as a firefighter with the CFD.

The PHS pertains to your **ethics** and your **integrity**. You, as the applicant, must first complete the PHS by answering all questions accurately, completely, thoroughly, and honestly. Minimizing, blaming, and failing to accept responsibility will be closely monitored. Should you be allowed to continue in the process, your answers will be verified by a variety of methods, including a comprehensive file review and truth verification examination.

Should you be successful at Steps One through Five of the Firefighter Pre-Screening Process, you will be requested to participate in a truth verification Pre-Employment Polygraph (PEP) examination. The purpose of the PEP is to verify your truthfulness, and that you are the person you claim to be in your employment application forms, questionnaires, documents, and interviews.

Be advised that deceit, dishonesty, or non-disclosure concerning questions in any part of the application process will likely result in disqualifying you from this and any future employment competitions with the CFD.

However, if an applicant admits to having committed a serious and undetected criminal offence, or is deemed to pose a serious risk to the safety of others, the CFD may disclose specific information to entities with lawful authority to collect such information (e.g.: police of the jurisdiction, child protection agency, etc.)
