

Notice Posting Size Guidelines

The following notice posting size guidelines have been prepared to assist Planners when determining if a small or large format notice should be posted. For landuse and outline plan applications, the notice posting request should be based on the proposed land use(s). For Technical Planning applications a small notice should be used.

Low Density Residential Districts	R-C1L, R-C1Ls, R-C1, R-C1s, R-C1N, R-C2, R-1, R-1s, R-1N, R-2, R-2M, R-CG, R-G, R-GM	R-MH – see additional direction column	RM-H: A large format notice is required for a land use amendment; a small format notice will be used at the DP stage.
Housing District		H-GO – see additional direction column	H-GO: A large format notice is required for a land use amendment; no notice posting is required at the DP stage.
Multi-Residential Districts	M-CG, M-G, M-C1, M-C2, M-1, M-2, M-X1, M-X2	See additional direction column	Asmallformat notice is required in most cases, however a large format notice is required when: more than one low density parcel (e.g. 50' parcel) is being redeveloped; more than four units are proposed; multiple multi-residential districts are proposed; and/or commercial uses are proposed. This applies to both DP and land use amendments.
		M-H1, M-H2, M-H3	A large format notice is required for these land use districts.
Commercial Districts		C-N1, C-N2, C-C1, C-C2, C-COR1, C-COR2, C-COR3, C-O, C-R1, C-R2, C-R3	A large format notice is required for these land use districts unless site constraints and tenant considerations make a large notice impractical.
Industrial Districts		I-G, I-B, I-E, I-C, I-R, I-O, I-H	A large format notice is recommended for these land use districts.
Special Purpose Districts	See additional direction column	See additional direction column	Discretion to be used based on the impact to the adjacent lands. For minor applications that result in little or no impact a small format notice can be used.

Discretion to be applied if the land use amendment / development permit would result in minor changes to the exterior of an existing building.
Centre City East Village Districts	See additional discretion column	CC-ET, CC-EIR, CC-EMU, CC-EPR, CC-ERR, CC-ER	A large format notice is required for these land use districts unless site constraints and tenant considerations make a large notice impractical. Discretion to be applied if the land use amendment / development permit would result in minor changes to the exterior of an existing building.
Commercial Residential Districts	See additional discretion column	CR20-C20/R20	A large format notice is required for these land use districts unless site constraints and tenant considerations make a large notice impractical. Discretion to be applied if the land use amendment / development permit would result in minor changes to the exterior of an existing building.
Mixed Use Districts		MU-1, MU-2	A large format notice is required for these land use districts unless site constraints and tenant considerations make a large notice impractical. Discretion to be applied if the land use amendment / development permit would result in minor changes to the exterior of an existing building.
Land Use application to allow for multiple districts, not associated with an outline plan		See additional direction column	A large format notice is to be used in most situations. Discretion to be used based on the land use districts proposed.
Direct Control Districts	See additional direction column	See additional direction column	Discretion to be used in accordance with the base district notice posting requirements.
Modifier changes	See additional direction column	See additional direction column	Discretion to be applied based on the changes proposed.
