Action Items

- 1. L.Shannon to proceed with the assumption that the WID online mapping solution will be refreshed with updated information every 24-hours. Real-time accuracy is not required.
- 2. WSPs to confirm if exporting geospatial data GeoJSON format is enough to allow for WSP import of data into their GIS systems.
- 3. M.Gray will send S.Ohama streetlight pole drawings to circulate to WSPs.
 - Each WSP will send S.Ohama general specifications for small cell on street lights for circulation to M.Gray and other City subject matter experts as required.
- 4. S.Ohama and colleagues are meeting with the Community Planning Director to discuss siting protocols (e.g. type D exemptions). WSPs to email comments prior to 2019 October 23.
- 5. M.Gray to follow up on co-location.
- 6. If not completed already, WSPs will identify privacy and media relations staff members who may assist with distributing information on 5G.

 - o The City and WSPs will continue to collaborate on crafting any common FAQs.
- 7. WSPs will provide comments on any timeline expectations.
