Ian Lawson asked Administration to clarify why the same police check is not sufficient for all classes of drivers licence – Taxi Driver's Licence (TDL), Limousine Driver's Licence (LDL) and Transportation Network Driver's Licence (TNDL).

Administration confirmed that the TDL/LDL police check is not accepted for TNDLs and that this is because of the Province's Transportation Network Companies Regulation. There are different police checks for TNDLs than TDLs/LDLs due to the specific provisions of the Transportation Network Companies Regulation relating to Police checks for TNC drivers.
