2018 Funding Reviews

If your FCSS Funding Agreement ends on December 31, 2018, you will be contacted by your social planner by the end of May 2018 for a funding review which will be scheduled between June 1 – September 7, 2018. Multi-Year Funding Applications were enabled in the FIMS database beginning May 22, 2018. All Multi-Year Funding Applications are due on **Friday, September 14, 2018**.

Crime Prevention Investment Plan (CPIP)

A new funding strategy for the Crime Prevention Investment Plan (CPIP) has been released to ensure investments are directed towards measurable social development projects that will reduce crime and increase community safety in Calgary. Two research briefs have been completed that will guide future crime prevention investments. A call for funding proposals aligned with this investment strategy will be launched this summer. Funding Information Management System (FIMS) Update:

FIMS/myID Accounts

Accessing FIMS: If your organization has previously obtained a BID #, a myID account and you have successfully logged in and set up a profile in FIMS, it is not necessary to acquire a new BID and myID account. Organizations who do so will have two accounts in the system which will delay the application process.

Please note that if you have not already done so, the following documents should be uploaded on your FIMS account to ensure that your contractual obligations are met and your organization's current documents are on our files:

- Certificate of Incorporation
- Certificate of Amendment
- Special Resolution
- Board Governance Policies
- Human Resource Policies
- Financial Policies
- Volunteer Policies and Practices
- Communication Plan
- Business Continuity Plan
- Business Plan – Program – Project
- Strategic Plan
