

Background

- City ownership of parklands along the Elbow River since the 1950s
 - parcel bounded by Britannia Dr., 50 Ave.
 SW and utility corridor
- 1980s River Park designated offleash dog area
- 1982 leases for days camps, school
- 1994 previous design development planning process





June 2007


- River Park Steering Committee
 recommends short-term maintenance and
 long term planning to address physical
 issues and user conflicts in River Park
- Issues of overuse and deterioration also affect bordering parks of Sandy Beach and Britannia slopes
- Parks are part of regional and contiguous open space park system
- The City decided to undertake a comprehensive planning process to address the management and design needs of the parks



The Parks

- River Park | Sandy Beach | Britannia Slopes is within Elbow River watershed
- Combined park areas total approximately 90 hectares
- Passive park with a variety of recreational uses (rafting, cycling, dog walking, jogging)
- Often perceived to be a neighbourhood park
- Part of larger regional system of river valley parks
- Linear, connected open spaces play a special role in protecting the environment and ecology as well as providing public access to the river




