Issue: Park Sustainability

- Park sustainability is in question, as a natural or urban park
- Health and sustainability of this park should be the #1 priority it is more about the park than about us
- Preservation of natural space (reserve)
- Restoration, access, sustainability
- Keep natural vs. more development (water park, concession)
- Overarching objective for the parks a) keep it as natural as possible
 b) urbanize the park

- Erosion of banks by dogs/ people/ water flow

- How to deal with flat part of River Park
- Degradation due to off leash
- Rotate off leash use through different areas
- Like what they do in New York & other cities
- Limit use of natural environment parks and encourage in other parks
 - Open new park space
- City is proposing to increase # of off leash areas in Calgary
- Have rotating off leash use within park
- Off leash use contributing to degradation will opening entire park to off leash worsen this?
- 50th Ave. to 45th Ave. has worst degradation
- North of 45th Ave. isn't as bad

- Ok to walk through on leash to get to off leash area?
- Surrounding developments using park contributes to environmental degradation
- Leased area could be freed up as valuable green space
- Areas of heavy use relate to parking
- Dog droppings left in park is a problem
- Others said they have observed dog walkers picking up not enough is being removed
- Regulate professional dog walkers in park
- Erosion of river bank due to dam not being dredged
- Also being caused by human use
- Better management of dam needed
- Concern about erosion on flat area of River Park because of reduced vegetation
- Need grass more tolerant of high traffic
- Hard to limit # of people?
 - Increased parking doesn't help
- Idea of levy on new development to pay for management of park
- Issue with regional status of park
- Problem of concentrating use in park despite other green/ open space in area
- Follow all of The City's policies regarding green space
- Issue of weeks replacing vegetation that has been degraded
- Dog urine and feces of great quantity at River Park is creating unhealthy soil chemistry
- Dog compaction of soil and claw action destroys turf
- Dog compaction and urine around base of trees kills roots of trees
- Over use with dog walkers with 8-12 dogs: dogs create more erosion because of lack of supervision and sheer numbers
- Protective fencing has helped temporary or long term
- Rotating off leash 1/3 of park
 - Difficult to control
 - o Fencing/ Bylaw Enforcement
- Idea of fencing area around pathway for off leash
- Concentrating use in one area may worsen degradation
- Parks to conduct density study for Altadore to determine future use/ pressure?
- Designate sufficient park space in new communities such as Currie Barracks
- New vegetation should be planted according to plan don't plant new trees/ shrubs until a plan is in place
- "Park calming" measures
 - Reduce parking
 - o Similar to measure to control traffic in Elbow Park
 - Restrict commercial dog walking
 - No parking zones on 14A St.
 - o If you build it (parking) they will come
- Consider a resident group to work with Parks oversight & input on design process
- Improve transparency & buy-in by residents
- Reduce mistrust
- Enforcement should be increased re: dog use
