Post discussion comments from participant with request to add to comment sheet If we look at the three parks as one regional park, will this result in:

- More than 30% of River Park flat area being designated off leash per the Off Leash Management Plan?
- A regional park not requiring a comprehensive, consultative process by the City with the Community Associations which represent individuals living adjacent to each individual park?

Most off leash users and other users of River Park flat area use River Park as the point of entry and do not use Sandy Beach and Britannia Slopes, and therefore, River Park and adjacent community should be considered separately.
