The ongoing exchange of information will be beneficial in strengthening our intermunicipal relationship.</p> <p>The objectives of the IMC are to:</p> <ul style="list-style-type: none"> a) Establish working relationships to assist in implementing mutual objectives; b) Maintain positive intermunicipal relations while seeking to resolve intermunicipal disputes that may arise; c) Improve the knowledge of each other's interests; and d) d. Provide direction on lands and matters of mutual interest.

	<p>The elected officials from each municipality are appointed by each Council at their respective organizational meetings for membership on the IMC.</p> <p>Only elected officials from The City of Calgary and The City of Chestermere are considered members.</p> <p>If the appointed member cannot attend, an alternate may be designated.</p>
TERM:	1 year

MEETINGS:	<p>Minimum of twice a year.</p> <p>Meeting locations typically alternate between City of Calgary and City of Chestermere offices.</p> <p>Meetings may be held at alternate locations deemed appropriate by the members.</p>
QUORUM:	1 elected official from each municipality to be in attendance.
