## **The 2025 General Election is here**

Eligible voters can cast their ballots for the 2025 General Election starting Oct. 6, 2025.

During Advance Vote, from Oct. 6 to Oct. 11, voters can vote at any of the Advance Vote stations, regardless of the ward in which they reside.

On Election Day, Oct. 20, voters must vote at their designated voting station.

Voters can use the Where Do I Vote? tool on the Elections Calgary website to find their nearest Advance Vote location, as well as their designated voting station on Election Day.

Special (mail-in) ballots are available for request for voters who cannot vote during the Advance Vote or on Election Day for any reason. The last day to request a mail-in ballot to be mailed to you is Oct. 3. The last day for in-person pick-up is Oct. 20 at 10 a.m. All mail-in ballots must be received by the Elections Calgary office by 12 p.m. (noon) on Oct. 20. Mail-in packages can be requested online or by calling 403-476-4100.
