







# 2014

Residential Property Taxes and Utility Charges Survey

This year's survey of participating Canadian municipalities contains information on the 2014 taxation year. The survey was conducted via e-mail with participating Canadian municipalities in 2015. All survey responses are published. Please note that some participating municipalities chose not to answer some questions. As such there may be different

## Methodology

A preliminary survey was sent out in the spring. Responses have come in over the subsequent months and we have made several efforts to confirm numbers with survey participants. In some cases additional information was collected from audited financial statements, annual budgets and property tax bylaws. Many municipalities had difficulty answering the electricity question so we collected rate information from electric utilities serving those municipalities and made those calculations, detail on those calculations is available on request.

Utility numbers were collected or calculated under these assumptions: 600 kWh usage of electricity, 19 cubic meters of water usage and 17.5 cubic meters of waste water disposal per a "typical" month consisting of 30.4 days. Other charges; recycling fees, garbage disposal and other are on a per residential dwelling basis.

The "representative bungalow" used in this survey continues to be defined as:


Twenty-five to thirty-years-old, single detached, three-bedroom bungalow with a main floor area of 1,200 square feet, a double car garage and finished full basement, on a 6,000 square-foot lot located in an average neighbourhood of the city.


The "representative two-storey" is defined as:


A 2 storey, 3 bedroom, 2 bathroom, single family house with double attached garage or car port with an average 1,500 square feet of above grade living space (including only those houses with 1100 to 1900 square feet into the calculations), located in an average neighbourhood.


Please note: the practice in Vancouver is to have a semi-finished crawl space instead of a basement so there are no "representative single family houses" in Vancouver. In keeping with their prior participation in this survey Vancouver provided average taxation information across all single family homes instead.


New this year Table and Chart 5 is now reported in Net terms, net of home owner credits. This impacts only the municipalities of Vancouver and Winnipeg.


















