Note 1a: Edmonton's Electric Power Franchise Fee is consumption based. Rates are set annually to meet a revenue target. The 2023 revenue target is \$76.418M (7.1% higher than the 2022 target of \$71.325M). Note 1b: The 2023 rate is \$0.0049/kWh for direct connect customers and \$0.0105/kWh for distribution connect customers.

Note 2a: Medicine Hat's Municipal Consent and Access Fee is mostly consumption based. Rates are set periodically for different customer classes, rather than a uniform rate across classes. Note 2b: The current rate (approved in September 2022) for residential natural gas customers has a fixed component at \$0.08844 per day and a variable component at \$0.16212 per GJ. Note 2c: The current rate (approved in September 2022) for residential electricity customers has a fixed component at \$0.03943 per day and a variable component at \$0.00203 per kWh.
