

The ePIC Online System allows for agencies to register online for an agency account profile. The registration of an account is subject to the approval of the CPS PIC Administration. Once approval has been provided to the agency, the agency will be available for new PIC applicants to be able to select when performing their PIC online. Also, the agency contacts can sign into the system and start to review applicant results shared with their agency.

Agencies do not need to be registered, applicants applying to non-registered agencies will receive a hardcopy letter in the mail.

However, if you wish to receive online notifications of shared results, have the option to pay on behalf of your applicants and view results through a convenient online portal, please register for an ePIC agency account. Registered agencies will also be able to accept shared results from other agencies, making it more convenient and time efficient for both applicants and agencies.

Welcome

Calgary Police Service, Police Information Check has added NEW FUNCTIONALITY to the electronic Police Information Check (ePIC) online system, allowing more individuals who currently reside in Calgary the ability to apply for their Police Information Check (PIC) online.

WHAT'S NEW

- Equifax ID verifier has been replaced with applicants submitting a selfie photo holding the same two pieces of government issued ID they will be providing with their application
- Applicants can now apply online for non-registered ePIC Agencies "Agency Not Listed"
- Applicants may apply online for "Immigration" and "Other" purposes
- · Minors over the age of 12 can apply online

PIC for ePIC Registered Agencies - Applicants will receive their Police Information Check result electronically. Once shared with the primary agency, Applicants can electronically share their result with other registered ePIC agencies that accept shared results. (Includes Volunteer Alberta VSPN registered agencies)

PIC for Non-Registered Agencies (Agency Not Listed) - Applicants will type the name of the Agency and will receive their Police Information Check in the mail. Applicants can electronically share their result with other registered ePIC agencies that accept shared results. (Excludes Volunteer Alberta VSPN registered agencies)

PIC for "OTHER" purpose - Applicants must provide name of Agency. Applications for "Personal Reasons" will be rejected.

Please note for the purpose of the ePIC online system the term "Agency" will also include reference to a company or an organization.

TERMS OF SERVICE

The **Terms of Service** page will be the first page displayed when registering for an agency account profile with the ePIC Online System. This page will summarize the process of approval for new agency account profiles with the CPS PIC Administration, all required information to successfully create an agency account profile on the system and the regulations for creating an agency account profile.

Once you have reviewed the contents of this page and agreed to the terms of service, advance in the agency account profile creation process by click the **Continue** button.

Registering and Creating an Agency Account-

Agencies must have a Head Office in Canada to be permitted to create an Agency account profile and utilize the ePIC system.

Agency representatives are required to register all detailed information regarding the Agency in order to create an Agency account profile. Agency representatives, referred to as 'Contacts', will have the capability to login with their unique credentials (email and password) and represent the Agency on the ePIC online system.

An Agency may have a minimum of 1 Contact to a maximum of 3 Contacts.

An Agency email will be required for each Contact person to successfully create an account.

The Agency name must be in the domain of the email address- generic email addresses will not be accepted.

Agencies will indicate if their Agency works with the Vulnerable Sector and if a Vulnerable Sector Search is required.

Agency account profiles will be approved by the Police Information Check prior to being available on the ePIC Online System. The account created for the Agency will not be activated until approved. An email notification will be sent to the Agency Contact(s) upon approval.

Returning Agency Contacts may login to the ePIC Online System by clicking on the Login With Existing Account option, to access the secure login prompt.

Agency profile and/or credit card information may be updated at any time by logging in to Agency Dashboard - Change Account Information icon.

Contacts -

Contacts will receive automated email notifications when a PIC application result is shared with the Agency.

Contacts may also view, save and print applicant results for a period of 12 months from date of completion.

If an Agency account has been inactive for 6 months the ePIC Online System will send an automated email notification to the Agency Contact(s) 14 days prior to the account being marked as inactive and archived in the system. Contacts will be able to continue with their Agency profile or delete the account. If no action is taken the account will automatically be deleted within 14 days from receiving the email notification.

VSPN-

The Volunteer Screening Program (VSP) is administered by Volunteer Alberta. As part of the financial assistance portion of VSP, eligible non-profit organizations may receive a Volunteer Screening Program Number (VSPN).

As of July 1, 2017, a Volunteer Screening Program Number (VSPN) is required to access the Fee Waiver.

Eligibility criteria applies! Visit the VSP website to see if your organization qualifies or to submit an application.

Payment -

Agencies have the option to pay for their applicants' PIC's. Credit card information will be required in order to link to the City of Calgary ePayment system. A Payment Card Inquiry compliant environment securely stores credit card information outside of the ePIC Online System.

Letters -

Agencies working with volunteers or unpaid practicum students, will need to supply their applicants with a Volunteer or Unpaid Practicum Letter. This letter is to be uploaded onto the ePIC online system when an applicant applies for a PIC.

Letters must be on the agency's letterhead and include the following information:

- Date
- · Applicant's full name
- Position of the volunteer or unpaid practicum
- VSPN and approved position code(s) (if applicable)
- Signature of the Agency representative or designate (Electronic signatures will be accepted)

Without a letter, applicants will be charged for a standard PIC.

View-Print-Save –

Agencies have the option to view, print, or save applicant results for their intended purposes directly related to their Agency only. Note: Applicants are not able to print/email/save their PIC letter/results for security purposes.

Share-

Agencies cannot share Applicant results or disseminate to any other person or Agency. All information shall be destroyed after use or maintained in such a manner to prevent unauthorized access.

Applicants may share their own information directly with others or other Agencies. Information supplied by the Applicant cannot be altered in any manner.

If an Applicant chooses to share a PIC result, which was originally completed for another Agency, the onus will be on each Agency to decide if they wish to accept a shared PIC. Agencies will determine if the purpose of the PIC is relevant for their own purposes.

Vulnerable Sector/No Vulnerable Sector -

Applicant shared results which have not had a Vulnerable Sector Search completed will NOT be permitted to share with an Agency, whom has identified a Vulnerable Sector Search is mandatory for their Agency.





Disclaimer -

PIC's can only provide information found at the time of the check, based on information provided by the applicant. The Calgary Police Service does not guarantee completeness of the results and is limited to information available on search databases. The search does not include information found in any other jurisdiction's local police information systems; nor does it include court information from any other provinces, except convictions registered on the National Repository for Canada, and information entered onto the Canadian Police Information Centre system. Checks are based on Canada-wide information only.

AGENCY INFORMATION

The **Agency Information** page will collect all of the detailed information regarding your agency account profile. This information will include specifics regarding the agency details (address, mailing address) and the contacts to be able to login and represent the agency on the ePIC Online System.

The following fields are mandatory on the page, and must be filled in prior to advancing to the next step:

Agency Name

• Multiple agencies cannot have identical agency names. If your agency name is already registered, you must provide a unique name to differentiate your agency. (IMPORTANT to ensure you provide your exact agency name to all of your applicants when they are to apply online). Agency selection cannot be modified after an application is submitted.

> Office Telephone Number

> Head Office in Canada

• You are also required to have a head office in Canada. If you do not have a head office in Canada, you will not be able to advance in the registration process.

> Vulnerable Sector

- During the registration process you will also indicate whether or not your agency works with the Vulnerable Sector.
- You will also confirm if all your applicants require a Vulnerable Sector Search. If not required for all applicants, please ensure you advise those applicants they <u>DO NOT</u> require a Vulnerable Sector search. Otherwise, a vulnerable sector search will be conducted automatically.
- The Vulnerable Sector (VS) requirement is intended for individuals who are specifically in
 a position of trust or authority of a person's care, that being a youth/child, elderly,
 temporary and/or permanently disabled, patients in care and responsible for the wellbeing of a child or vulnerable person. To meet the legal requirements for a vulnerable
 sector check, the nature of the position – not the person – must cause the person to
 have authority over, or trust of, children or vulnerable persons. The vulnerable sector
 selection cannot be modified after an application is submitted.

VIEW APPLICANT RESULTS

The **View Applicant Results** page allows an agency contact to easily view shared application results online. The results displayed on this screen are individual Police Information Check applications that have been shared by applicants with the associated agency. Results will be automatically sorted by the date submitted with the newest PIC application on top.

The View Applicant Results page will be separated into two (2) sections:

- > New Results
 - The **New Results** section will display all PIC applications shared with the agency that have not been viewed by an agency contact.
- Previously Viewed Results
 - The **Previously Viewed Results** section will display all PIC applications shared with the agency that have been viewed by an agency contact.

Once an Agency Contact has viewed a shared applicants' result, it will automatically move to the Previously Viewed Results tab.



APPLICATION RESULT(S)

The **Application Result(s)** page will display the result documents of a Police Information Check application that has been shared by an applicant with the agency.

The agency contact can easily view the result documents online by clicking the **View** option which will allow the agency contact to view the document online and print. The document will be automatically watermarked in the top right corner with a box that reads **Printed by AGENCY NAME on DATE.** The agency contacts have the ability to also save the documents to their desktop. Click the **Save** button which will provide the agency contact with the same document but will include a watermark of **VOID** over top of the document.

Once agency contact views the New Results, result will be moved to Previously Viewed Results.

The results displayed in **Application Result(s)** will only be available to the agency contact for **1 YEAR**. After which, the results will be automatically purged from the ePIC Online System including all personal information, uploaded documents and results.



The columns displayed in the listing are the following:

Reference

The Reference # column is the automatically generated number assigned to each submitted PIC application and displayed on successful submission. The Reference # is used to quickly refer to the PIC application if applicant or agency requires assistance or has questions related to the PIC application.

Date of Result

The Date of Result column is the date the Police Information Check (PIC) was completed.

Name

The Name column is the name of the applicant that requested the PIC application.

Document

The Document column shows the result of the completed PIC as well as whether a Vulnerable Sector search was conducted.

Vulnerable Sector Search

The Vulnerable Sector column is the value provided by CPS PIC if the Police Information Check was put through a Vulnerable Sector Search.

CHANGE ACCOUNT INFORMATION

The **Change Account Information** page allows the agency contact to update the agency account profile. This information will include specifics regarding the agency details (address, mailing address) and the contact to be able to login and represent the agency on the ePIC Online System.

Your agency contact has the opportunity to add and remove contacts with a maximum of two (2) additional agency contacts as contacts to the agency account profile. These contacts will have the ability to receive automated email notifications when a PIC application result is shared with the agency, and view application results shared with the agency when logged in. **Please note that each contact for an agency has their unique login credentials (email and password)**. The password for additional contacts added to the agency account profile will be established after the updates to the agency account profile have been successfully approved by the CPS PIC Administration.



Once the agency contact has made the necessary adjustments to the agency account profile and has clicked the **Save and Update** button an automated email notification will be sent to the CPS PIC Administration to review and approve the changes to the agency account profile.

Once the CPS PIC Administration has approved the changes to the agency details, an email notification will be sent to the agency contacts.

APPROVE PENDING APPLICATIONS – payments for applicants

The **Approve Pending Applications** page will display all of the pending Police Information Check submissions to the agency waiting for approval or rejection for immediate payment. This **Approve Pending Applications** section will only be available to agencies that have indicated that they will be paying for Police Information Checks for their applicants.

Agency contacts will receive an email notification to inform them that a Police Information Check is awaiting approval on payment. If this email is not acted upon within <u>14 DAYS</u>, the **PIC application will be deleted from the ePIC system.**
