Please note as x,y coordinates allow data to be individually identifying, disclosing such information is subject to the Alberta Freedom of Information and Protection of Privacy Act (FOIPPA). Under Section 17(1) of the Act, "the head of a public body must refuse to disclose personal information to an applicant if the disclosure would be an unreasonable invasion of a third party's personal privacy." Section 1(n)(i) of the Act defines "personal information" as "... recorded information about an identifiable individual, including the individual's name, home or business address or home or business telephone number". As an x,y coordinate is an alternate way of recording an address for mapping purposes, any CPS data including x,y coordinates would fall under this definition. Section 17(4)(b) of the Act defines "an unreasonable invasion of a third party's personal privacy" as the disclosure of personal information that "... is an identifiable part of a law enforcement record..."

Associating charging information or a 'crime' to an address is identifiable as a law enforcement record and therefore, disclosing such information would meet this threshold. As a result, CPS is not able to provide data by x,y coordinates.
