Mandate:


• Utility infrastructure design & construction.

Outcomes:

• Reliable, transparent, safe, collaborative, effective & efficient delivery of our projects.







Calgary 🚳 Utilities Delivery – Overview for 2023-2026

The 2023-2026 One Calgary Service Plans & Budget was approved by Council on November 25, 2022:

- \$1.4B for Water, Wastewater, and Stormwater
- \$116.5M for Waste & Recycling

Approximately \$340M of 2023 projects being delivered







Process Infrastructure Delivery (PID):

- Fish Creek WWTP Upgrades \$169M (2023-2026)
- Bonnybrook Plant D Expansion Program \$67M (2023-2026)
- Fluoride Re-Integration Bearspaw & Glenmore WTP \$12M (2023)
- Compost Facility Expansion \$50M (2023-2025)



Linear Infrastructure Delivery (LID):

- North Water Serving Strategy \$82M (2023-2026)
- Community Drainage Improvements \$51M (2023-2026)
- Trans Canada Sanitary Trunk \$82M (2024-2026)


Water Treatment

- Fluoride Re-Introduction at Bearspaw and Glenmore Water Treatment Plant – Q1 (Construction)
- Bearspaw Raw II Pump Station Upgrade Q2 (Construction)

Wastewater Treatment

- Fish Creek Wastewater Treatment Plant Diversion Chamber Upgrades – Q2 (Construction)
- Fish Creek Storage Building Q3 (Construction)

Electrical, Instrumentation & Controls

Calgary

- Fish Creek Wastewater Treatment Plant Electrical Upgrades – Q4 (Construction)
- Electrical Engineering Consulting Services for the Water Utility and Waste and Recycling Services – Q2 (Consulting Request for Standing Offers (RFSO))
- Pine Creek Lighting Upgrades Q2 (Consulting)




Utilities Delivery PID – 2023 Project Highlights

Waste & Recycling

Calgary

- \$27M capital projects going to market this year
- Construction related scope categories:
 - Maintenance
 - Landfill Gas
 - On-Site Stormwater Management
 - Cell Construction/Capping
- Projects include:
 - East Calgary Landfill Cell Construction Q1
 - Landfill Cap Remediation & Maintenance Q1
 - Active and Closed Landfill Gas System Maintenance and Upgrades – Q2
 - East Calgary Landfill Gas Expansion Q1
 - Shepard Landfill Stormwater Management Q3



Utilities Delivery LID – 2023 Project Highlights

Upcoming Construction Tenders:

Approximately \$170M of projects going to market: <u>Water:</u>

- Watermain replacement Q1
- Main replacements Q1

Wastewater:

Calgary

- Inglewood Sanitary Trunk Q1/Q2


