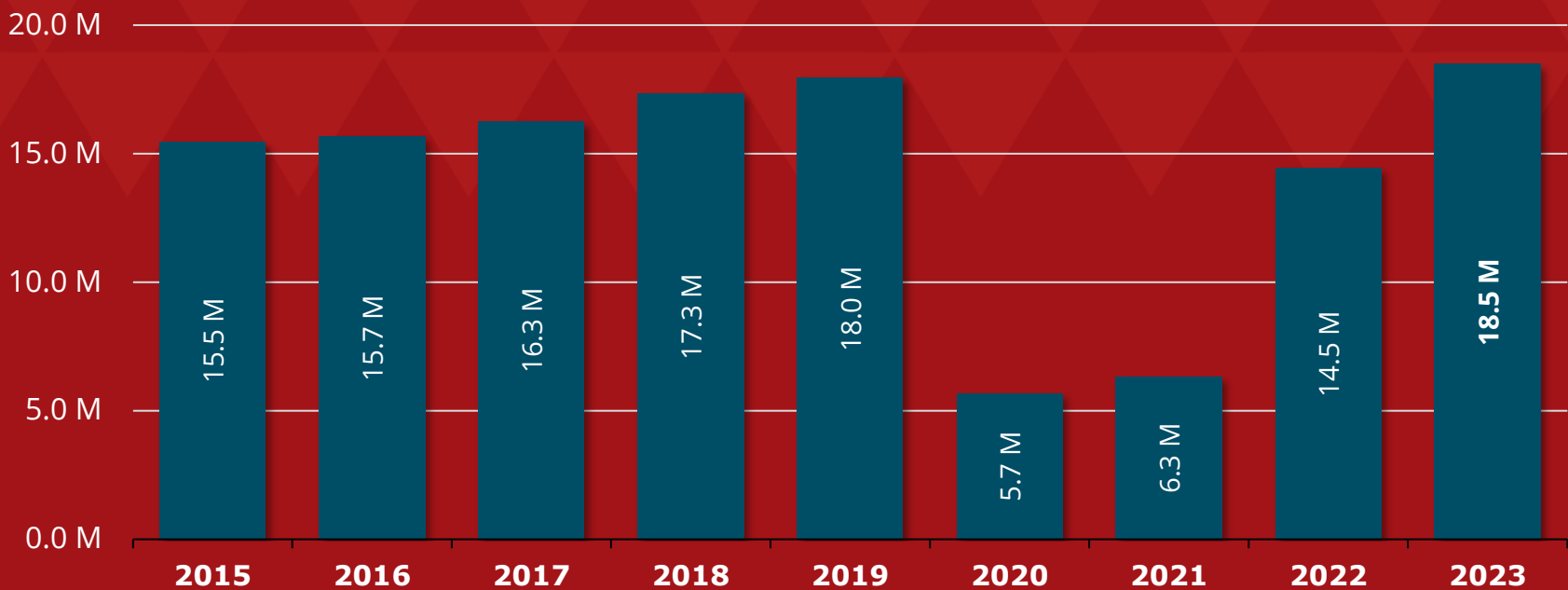

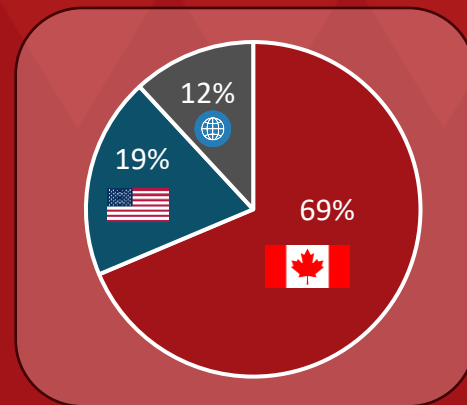

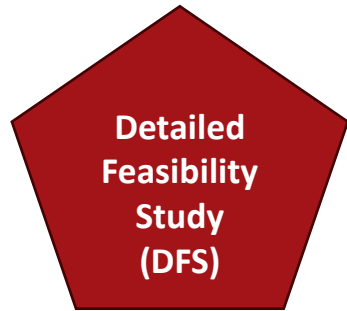


# NET-ZERO Roadmap

## Purpose:

1. Reach Net-Zero Emissions by 2050
2. Reduce Scope 1 & 2 Greenhouse Gas Emissions by 30% of 2018 baseline by 2026

**2024**



- Selection of an Energy Service Company (ESCO) is underway
- The ESCO will conduct a Detailed Feasibility Study (DFS) to further develop the Net-Zero Roadmap while identifying project retrofit initiatives to meet corporate sustainability and energy management objectives.

**Purpose:** To consolidate pre-board screening locations within the Domestic Terminal Building (DTB). Multi-Phase, Multi-Year Program



## Project Schedule

- ⇒ Consulting RFP – Q1 2024
- ⇒ Construction Manager RFP – Q3 2024
- ⇒ Construction Start - Q4 2024
- ⇒ Phase 1 Go-Live – Q1 2026
- ⇒ Phase 2 Go-Live – Q4 2026
- ⇒ Ancillary Projects – Q4 2026-Q4 2027
- ⇒ Project Completion – Q1 2028

# Non-Passenger Screening for Vehicles

**Purpose:** Relocation of the existing south NPSV Facility, including roadway and queuing area, vehicle canopy, new screening facility, washroom and lunchroom.

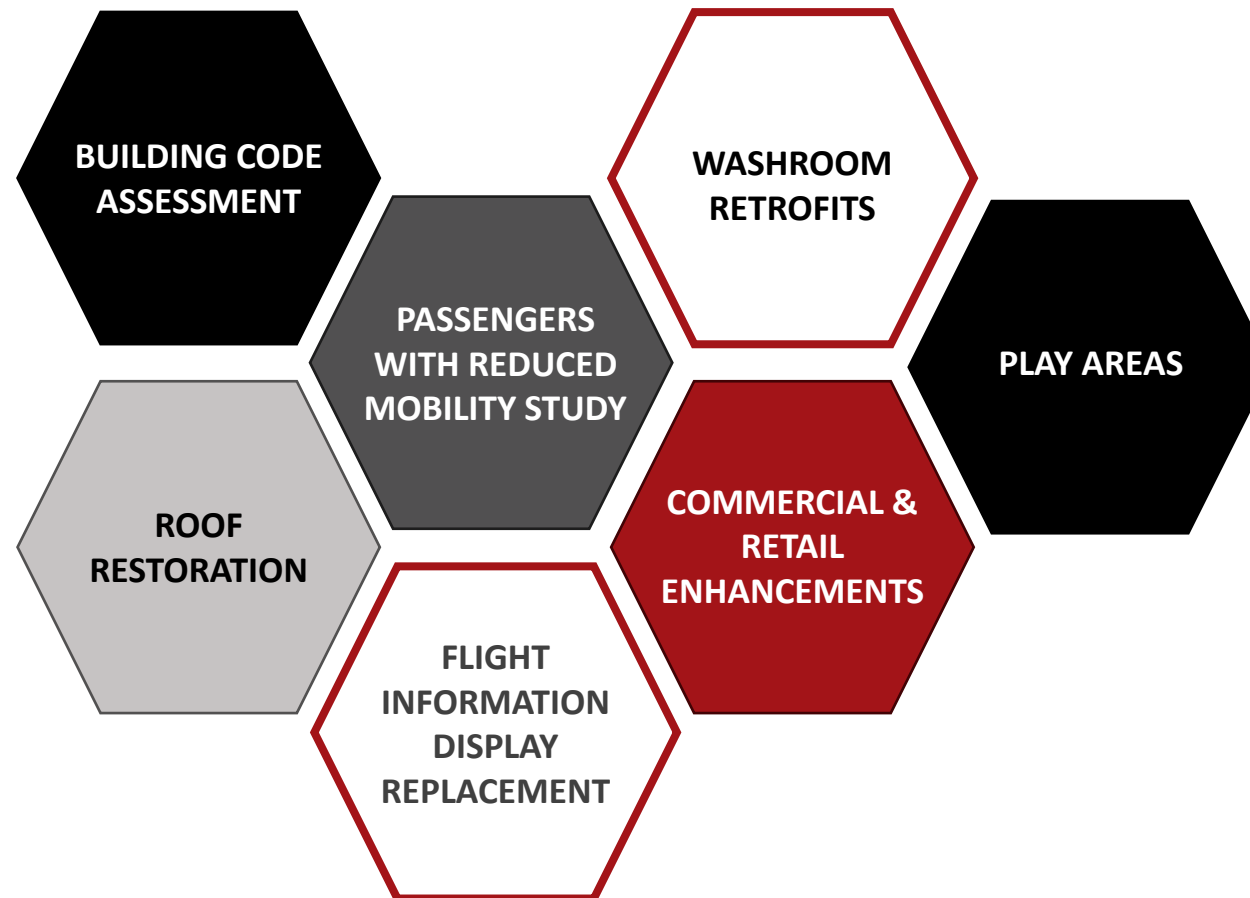
