# Public Education Campaign – Availability of Accessible Taxis

Administration informed the Subcommittee that, with respect to the 2017 February 9 Motion Arising, communication planning support will not be made available by Administration to raise awareness among Calgarians that wheelchair accessible taxis are available to all taxi users.

The Subcommittee discussed conducting further investigation into the risk of further erosion of on-demand wheelchair accessible taxi services. A number of Accessible Taxi Plate Licences (ATPLs) have already been surrendered. Other areas of investigation include evaluating how many of the remaining ATPLs are made unavailable to provide on-demand wheelchair accessible services due to other contracts (e.g., airport, Calgary Transit Access), and how many others are at risk of surrender on the basis of usable vehicle life cycle considerations. This analysis would help the Subcommittee evaluate how much time (in months and/or years) until the situation may become critical and, in turn, help the Subcommittee decide whether or not to recommend that LTAC allocate resources for the external procurement of public education activities. The goal in raising awareness among Calgarians that street hail wheelchair accessible taxis are available to all taxi users is to support the sustainability of ATPLs.

Motion by Lauri Brunner that the CER subcommittee recommend to LTAC that this matter be referred to the Plate Utilization subcommittee to conduct further investigation into the areas discussed. **CARRIED**
