Customer Satisfaction Research Kick-off Meeting

The subcommittee reviewed the questionnaire from the 2016 telephone survey and requested several additions and deletions for the 2017 survey.

The 2017 survey will:

- Measure users of accessible taxi services as individuals who require an accessible taxi for the accommodation of a mobility device
- Clarify customer expectations with the "pre-book" method of obtaining taxi services
- Add a 'value-for-money' question for TNCs
- Reduce the number of 'awareness of rights' questions related to service quality
- Include additional questions on safety
- Add a follow-up question as to why a user might bypass and accessible taxi or nonaccessible taxi van
