CALL TO ARTISTS

The City of Calgary is now accepting applications for one sculpture project in northeast Calgary. Artists and artist teams who are interested in creating a community sculpture are encouraged to apply.

This project is open to all artists who work, live, play or have strong ties to northeast Calgary. We encourage submissions from groups that are typically underrepresented including BIPOC (Black, Indigenous, and People of Colour) individuals, LGBTQ2S+ identifying individuals, francophone, deaf persons, and persons with disabilities.

The City of Calgary recognizes and values [diversity and inclusion](#) and unique dimensions of diversity including race, ethnicity, gender, disability, age, religion, sexual orientation, work style, communication style, learning preferences, newcomers, immigrants and others.

Accessibility

Public Art staff are available to work one-on-one with applicants who experience barriers to develop accommodations that suit their abilities. Examples of accommodations include translation of written materials, interpretation for meetings, braille transcription, physical access to meeting spaces and video or audio applications.

The City of Calgary is currently working with Calgary Arts Development (CADA) to provide access to translation services free-of-charge. Please contact CADA directly if you would like to access this service.

CONTEXT

The City is working on an exciting initiative that will bring several public art projects to Calgary's northeast communities.

The northeast public art project will have multiple phases and is expected to be completed in 2023. It will include multiple opportunities for the creation of public art in the form of bike racks, benches, picnic tables, mini-galleries, banners, sculptures, community events and a documentary that will feature the hired artists, community members, Indigenous Elders and Elders from culturally diverse groups in northeast communities.

The Calls to Artists for these projects will be released at various times throughout 2021 and 2022, with all projects completed by 2023.

In November 2020, City Council directed Administration to explore public art opportunities in Ward 5, with an emphasis on replacing the gap left by the removal of the *Wishing Well* at the Genesis Centre and further compensating for a historically inequitable distribution of public art funds in these communities.

This initiative is intended to provide more opportunities for artists that live, work, and play or have strong ties to the northeast communities. It will support the local economy and provide opportunities for the community to come together and create amazing spaces.

Some of the languages spoken in this area include, but are not limited to, Punjabi, Chinese, Urdu, Vietnamese and Arabic. We are inviting members of these communities, and others, to submit applications for these projects as they are released.

PROJECT DESCRIPTION

The northeast public art project is a multi-phase project that is expected to be completed in 2023. It will include multiple opportunities for the creation of public art in the form of bike racks, benches, picnic tables, mini-galleries, banners, sculptures, community events and a documentary that will feature artists hired, community members, Indigenous Elders and Elders from culturally diverse groups in northeast communities.

This call is for a community sculpture at the Genesis Centre.

Artists or artist teams can apply to be considered.

Successful artist/s will be presented with possible locations in Genesis Centre to create and install artwork.

Location

The Genesis Centre is a vibrant community hub that offers sports, wellness, cultural and social programs and resources in northeast Calgary.

Potential sculpture locations include the courtyards outside the main entrance to the facility or the courtyard on the north side of the building. Successful artist(s) will have an opportunity to tour the potential locations and discuss options and considerations with the facility operators, The City of Calgary, and with users of the space through the public engagement process.





Goals

This project will:

- Support local artists, businesses, and organizations.
- Enhance our northeast neighborhoods.
- Reflect the people who live in the communities where the art is located.
- Provide support for public art projects by professional artists at any level of experience.
- Encourage a diverse representation of artists, art practices, ideas, and topics.

Public engagement

To ensure the project is reflective of northeast Calgary and the people who live there, the artist or artist team will be required to attend and participate in a series of engagement activities with the public.

Engagement at The City of Calgary is defined as purposeful dialogue between The City and people that live, work and play in Calgary to gather meaningful information to influence decision making. Public engagement is not about voting or collecting representative information. It is about considering the input, ideas and perspectives of people who are interested or impacted by decisions before decisions are made. Our Engage policy and other details that outline engagement expectations, including the Engage Framework can be found at engage.calgary.ca/about.

In March and April 2021, we completed some early public engagement for this project and saw an astounding response. Nearly 6000 Calgarians participated in the engagement activities, which included a survey available in English, Punjabi, Urdu, Arabic, Vietnamese, Simplified Chinese and Traditional Chinese. Interpretation services were also available at five online workshops for Punjabi, Urdu, Arabic, Vietnamese, Mandarin and Cantonese speakers.

The ideas we received are inspiring. Each person we met had a unique story and gave us a true picture of what they would like to see for public art in their communities.

Collaboration with City staff

To ensure the public art project meets project goals, as well as the requirements of the Public Art program, the artist or artist team will be required to work closely throughout the project with Public Art program staff as well as other stakeholders.

The total budget is intended to include, but is not limited to:

- Artist fees
- Consultation
- Public engagement (artist time only)
- Travel
- Insurance
- Studio fees (if applicable)

HOW TO APPLY

Submission package

Eligible submissions must contain:

- a) **Letter of interest** (maximum of 200 words, including how the artist is connected to the northeast Calgary area). Letter of interest should answer the requirements in the evaluation criteria below.
- b) **A current resume/curriculum vitae** With applicable examples of work in related areas, educational experience, and contact information.
- c) **Up to five (5) images of past work** One artwork per image. Collage images are permitted. Include an image list with a brief description of the commission, title and date of each work, and information on project partners where applicable.

Academic qualifications are not required if applicants can demonstrate their experience and ability in their application.

Applicants are asked to demonstrate their experience building or working with builders to develop and create original artistic concepts.

The submission package will be evaluated based on the application criteria on the next page.

Note that artwork concepts (proposals) are **NOT** required at this application stage.

How to submit

- The maximum file size for an email is 10 MB.
- Submissions are accepted in electronic form only.
- All submission files must be compatible with a PC.
- Links to posted media or content will not be viewed. All content must be contained within the email.
- Incomplete or late submissions will not be considered.

References

Three references will be requested for shortlisted artists. References should include the person's name, company name and current contact information including telephone number, address and e-mail address. The City reserves the right to contact references without prior notification. References from City of Calgary staff members will not be counted as part of the required references. References can include previous employers, contractors, artistic peers and or community members.

Artist teams

If applying as a team:

- Identify the project lead and team members.
- Describe how the team will be structured including the role of each team member.
- Provide the percentage of time dedicated by each team member.
- Indicate the location where team will be based.



EVALUATION CRITERIA

- A. Understanding of the project: 40 points
- Why this opportunity appeals to the artist (10 points)
 - How the artist's background and practice will contribute to this project (10 points)
 - How the artist is connected to northeast Calgary area (20 points)
- B. Project experience: 20 points
- Experience in working to a schedule; demonstrated ability to deliver a project on a timeline (10 points)
 - Demonstrated ability to collaborate with project teams, other stakeholders and engage with the public (10 points)
- C. Artistic practice and impact: 30 points
- Demonstrated artistic excellence (10 points)
 - How the artist will foster community building and encourage communal conversations (20 points)
- D. Related experience: 20 points
- Demonstrated, relevant experience in working on object-based projects and managing budgets (10 points)

SELECTION PROCESS

Step 1 - Shortlisting

All eligible submissions are reviewed by a selection panel consisting of arts professionals, community members and Indigenous Elders. The selection panel will shortlist artists or artist teams based on how their submissions meet the evaluation criteria.

Step 2 – Finalist interviews

Shortlisted artists or artist teams will be invited to an interview session with the selection panel. Finalist(s) will be selected after the interview. Interviews are anticipated to be held in July 2022.

The selection panel has the right to not award any of the submissions, and The City reserves the right to cancel/reissue this opportunity at any time.



ABOUT CALGARY

The Calgary area where the Bow and Elbow rivers meet is a place of confluence where the sharing of ideas and opportunities naturally come together. Indigenous peoples have their own names for this area that have been in use long before Scottish settlers named this place Calgary. In the Blackfoot language, they call this place, Moh-kins-tsis. The Stoney Nakoda Nation refer to the Calgary area as Wîchîspa Oyade and the people of the Tsuut'ina nation call this area Guts-ists-i. The Métis call the Calgary area Otos-kwunee.

We would like to acknowledge that this project will be located on the traditional territories of the people of the Treaty 7 region in Southern Alberta. This includes: the Siksika, Piikani, and Kainai, along with the Blackfeet in Montana, collectively known as the Blackfoot Confederacy; the Îethka Nakoda Wîcastabi First Nations, comprised of the Chiniki, Bearspaw, and Wesley First Nations; and the Tsuut'ina First Nation. The city of Calgary is also home to the Métis Nation of Alberta, Region 3. We acknowledge all Indigenous urban Calgarians, First Nations, Inuit, and Métis, who have made Calgary their home.¹

One of the guiding principles of the Public Art Program is to share, and provide a voice to, the historical context of Calgary; honour that information, and include and embed it in the work going forward. THE PUBLIC ART PROGRAM

Our mission is to provide a responsive Public Art program from which The City, Calgarians and artists can collaborate, exchange perspectives and explore familiar and unimagined situations, subjects and opportunities as they relate to our evolving relationships with our shared history, place and community.

Established in January 2004, the program ensures the allocation of 1% for the portion of eligible project capital costs over \$1 million up to \$50 million; and 0.5% for the portion over \$50 million to public art.

The Public Art Policy outlines the diversity of public art opportunities as: discrete, semi-integrated, integrated and temporary works, and allows for artists on design teams, community-based public art, and special projects such as artist residencies.

The City of Calgary is gradually transitioning key components of public art program operations to [Calgary Arts Development \(CADA\)](#). During the transition period we are working closely with CADA on community programming, calls for artists, community engagement and the procurement of new public art. The full transition will be complete in 2024. Selected artists and artist teams may be asked to work with both organizations throughout their project. The City and CADA are committed to working with artists and Calgarians to creating a positive, meaningful and enriching program for the future.

WORKING WITH THE CITY

Prior to confirmation of award, the selected artist or artist team will be required to:

- Confirm status as a company or sole proprietorship.
- Confirm a Commercial General Liability (CGL) insurance policy for bodily injury (including death) and property damage in an amount of not less than TWO MILLION DOLLARS (\$2,000,000.00) inclusive limit for any one occurrence.
- Sign a Scope and Fee contract defining project deliverables and payment schedule.
- Sign a City of Calgary Artist Agreement which includes Artist General Terms and Conditions.
