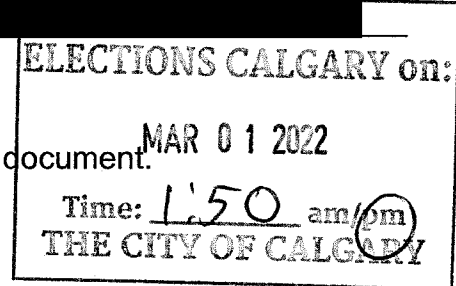



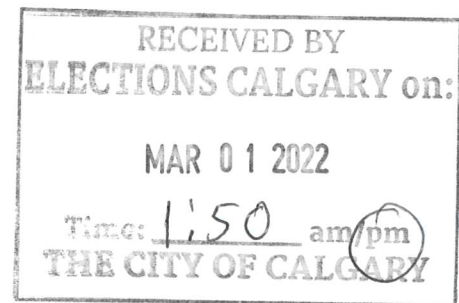

Management's Responsibility for the Financial Statement

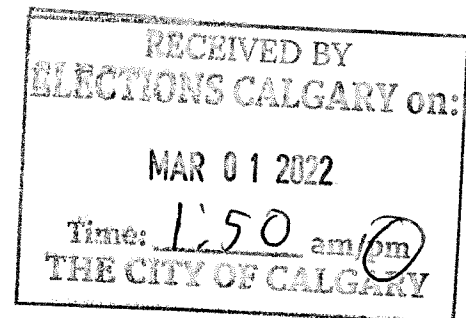

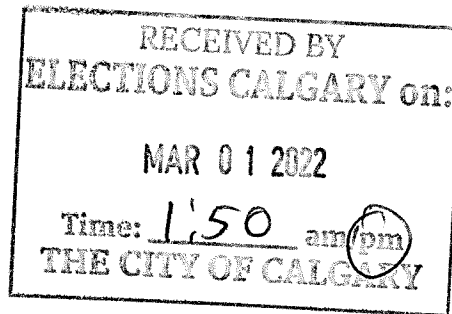


Conclusion

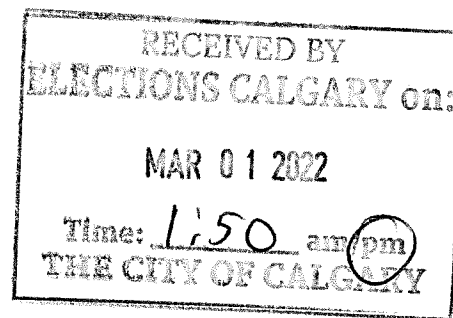
