Green Line Board April 2023 Public Progress Report

1.0 Executive Summary

In April, the Green Line Board approved the Development Phase Agreement and selected Bow Transit Connectors (BTC) as Green Line's Development Partner. BTC brings together Barnard Constructors of Canada, LP, Flatiron Constructors Canada Ltd, and WSP Canada Inc, along with their financial advisor EllisDon Capital Inc. Collectively they will bring shared expertise in underground, above-ground structures, and LRT design and construction to deliver Phase 1 of the Green Line LRT Project.

Delivery Partner (CSIX) onboarding activities, including planning, resourcing, and mobilization, continued in April, and the full Technical Advisory Services Team has been onboarded in preparation for the Development Phase.

On April 6, 2023, the Eau Claire Land Use / Area Redevelopment Plan (ARP) amendments were presented at Calgary Planning Commission (CPC), receiving unanimous support. The application is proceeding to the May 16 Council Public Hearing with CPC's recommendation for Council approval.

As planned, the LRV Preliminary Design Review (PDR) was completed on April 28. CAF LRV schedule performance is being closely monitored and managed.

Ongoing utility relocation works in Downtown and the Beltline continued through April (see detailed list of work in <u>Section 1.1</u>). The installation of new sanitary and storm lines along Olympic Way, between 12 Avenue and 11 Avenue S.E. were completed in April, and Enmax completed duct bank installation work along Bow River Pathway, west of 2 Street S.W.

1.1 April Construction Highlights


Construction activities in Beltline and Downtown continued during the month of April. Green Line continues to work to minimize construction impacts to the travelling public and coordinate construction activities among third-party utilities, PCL who is managing BDURP construction activities on behalf of Green Line, and The City's Mobility business unit.

Shallow utility relocation work (such as third-party telecom, electricity, and gas utilities) continues within Beltline and Downtown, in addition to engineering design works for the remaining shallow utility work. Deep utility relocation works in Beltline include City sanitary, water and stormwater utilities.

1.5 Risk Management

Risks are continually monitored by Green Line, some key risk items from April 2023 that are being addressed are:

- Green Line continues to monitor financial market changes due to the current economic climate.
 Regular external due diligence is ongoing to identify, evaluate and validate information and assumptions.
- Utility relocation works in Beltline and Downtown are ongoing in busy traffic corridors, which has a
 potential to impact travelling public and pedestrians. Green Line continues to proactively engage and
 notify stakeholders of potential construction related impacts (e.g., road closures) and is working
 actively with City business units on a regular basis to optimize traffic control, lane closures, and assist
 with traffic management in Beltline and Downtown overall.

1.6 Stakeholder Relations

BDURP construction continued in Beltline and Downtown with coordinated traffic and pedestrian detours in place to maintain area access. Traffic detours to facilitate transmission line work in Beltline West, resulted in delays for vehicles exiting parkades on 10 Avenue S.W. and 9 Avenue S.W. The team worked collaboratively with the Third Party Utility and the City's Mobility team to adjust the detour, including traffic signal timing, and improve traffic flow during peak travel times. Detours for this work will continue until July and will recommence post-Stampede.

Green Line continues to collaborate with Third Party Utilities to ensure impacted businesses are prepared, that access is being maintained, and business operations are considered during construction planning. For example, construction sequencing and the installation of a temporary loading area for coach and guest drop off/pick up have been implemented to support Westin Calgary hotel during construction.

On April 13, Green Line attended the Riverbend Community Association's Annual General Meeting to provide a project update, including the upcoming 78th Avenue Project construction in Ogden. On April 18, Green Line provided an update at Calgary Municipal Land Corporation's semi-annual Community Partner's meeting. On



April 26, Green Line met with representatives from Downtown property management companies to provide a monthly construction outlook. The responses at each of these events continues to be positive as people are eager to be kept informed.

In addition to the four construction notices sent to 79 stakeholders in Beltline and Downtown during the month of April, direct stakeholder outreach for April 2023 is summarized below.

Green Line curated a display in City Hall called "The Past, Present and Future of Light Rail Transit in Calgary." It showcases the history of Calgary's CTrain system from its humble beginnings in 1981 to the future additions of Green Line and expansions of the Red and Blue Lines. To help promote this display an animated video showing the growth of the CTrain system was shared on our social media channels.

Green Line also attended SUPERTRAIN over the weekend of April 15-16, which is Canada's largest model train show. There were 11,600 visitors to the event and Green Line spoke to thousands of Calgarians about the project.

2.0 Health & Safety

Green Line monitors safety compliance by Green Line staff, consultants, and contractors at construction sites. The Green Line office move to First Tower occurred safely with all emergency equipment put in place and all staff provided orientation to emergency procedures, muster point and equipment locations.

The following two property damage incidents occurred in April 2023:

- The first incident occurred on April 15 in Downtown at the intersection of 4 Avenue and 1 Street S.W. when a traffic signal communication line was severed. This had resulted in a short-term disruption to a traffic signal. As-built information was found to be incorrect and locate did not identify the presence of the communication line. In general, as-built information related to infrastructure in Downtown is old and not reliable. Green Line is working with The City Business Unit to determine preventive actions.
- The second incident occurred on April 21 in Downtown when a Third Party Utility contacted street light cable on 7 Avenue and 1 Street S.W. Same condition as noted above.



All incidents are being investigated and Green Line is following-up with the respective contractor and Third-Party utilities to identify and understand the root causes that led to these incidents and implement measures to address them moving forward. Safety remains a focus for Green Line as BDURP construction activity continues in the Beltline and Downtown areas.

The Green Line 2023 Safety Targets & Objectives were reviewed at the Annual Safety Management Review meeting. They were subsequently signed off and shared with all Green Line personnel.



Safety Audit

The safety audit action plan was finalized in

April based on the opportunities for improvement identified in the external 2022 COR audit report and was reviewed by management prior to submitting to the Audit Facilitator.

Green Line has retained the services of an external consultant to perform a safety audit. The audit is expected to be completed in May.

Green Line staff continues to work with an external consultant to audit the CM Contractor's Safety Management System.
