

User Guide: How to Apply for Tenancy Change

If a Tenancy Change application is required, you can apply for it at the same time as a new business licence application or building permit, apply online or in person at the Planning Services Centre. For more information, please review the <u>Tenancy change requirements list</u>.

1. Access the Website

- Visit apply.calgary.ca
- Select the "Start New Business Licence and/or Land Use Approval" tile
- This launches both new-licence and land-use workflows.



2. Log in or Register

• Sign in with your myID, or click "Register New Business Account" to create one.
