# Businesses in residential areas

Integrating small businesses—like offices and artist studios, or corner stores, personal services and cafés—into residential areas can enhance community vibrancy and convenience. The new Zoning Bylaw explores ways to bring appropriate businesses closer to home.

**Considering both benefits and trade-offs, how should zoning balance enabling neighbourhood businesses while keeping impacts on residents appropriate?**

## Key ideas

### Accessing businesses close to home

Introduce or expand shops and services allowed in residential areas to support local needs and vibrant, walkable communities.

### Flexible home-based business regulations

Update zones to allow a broader range of home-based businesses, supporting entrepreneurship while limiting neighbourhood impacts.

### Neighbourhood services

A new use called Neighbourhood Store has been added to the H-2 and H-3 zones to allow more local employment opportunities.

### Considerations

- **Convenience and context:**  
Allowing businesses in neighbourhoods increases local amenities but may raise concerns about noise, traffic, parking and privacy.
- **Economic opportunities and regulation:**  
Easing restrictions and clearly outlining the opportunities possible within neighbourhoods can encourage and support local businesses. Equally important, appropriate regulations are necessary to mitigate potential disturbances.

## Connections to the Calgary Plan

### Growth and city structure

- A broad range of mixing of uses are supported citywide, however the Greater Downtown and Neighbourhood–High Activity areas provide the greatest opportunity for the mixing of uses compared to other areas. More modest mixing of uses are supported in lower activity areas.

- **Climate Strategy:** Reducing the need for residents to travel for goods and services aligns with environmental sustainability objectives.
