NOTES:

Note 1: Authority: this schedule summarizes the fees collected with Business Licence applications and should be used for convenience only. For official fees, reference Business Licence Bylaw 32M98, Alarm Services Bylaw 31M95, Bicycle Courier Licensing Bylaw 48M90, Body Rub Licence Bylaw 53M2012, Concert Bylaw 4M83, Dating and Escort Service Bylaw 48M2006, Downtown Pushcart Vendor Licence Bylaw 3M97, Exotic Entertainers Bylaw 47M86, Extended Dance Event Bylaw 34M2000, and Massage Licence Bylaw 52M2012.

Note 2: Charitable organizations: charitable organizations may apply to receive a reduced rate on the Base Fee: \$94 for new applications and \$78 for renewals.

Note 3: Fire inspection fee: does not apply to home-based businesses. The Fire Inspection Fees are set by The Fire Fees Bylaw 40M2003 and are listed on this schedule for convenience only.

Note 4: Multiple licence types: when applying for multiple licence types at the same time, the fee will be calculated based on all approvals required, using the highest fee in the schedule. All fees will only be charged once.

Note 5: Planning approval fee: does not apply to home-based businesses. Home-based businesses require a Home Occupation permit. See the Planning Applications Fee Schedule for fees.

Note 6: Police Review Fee: where applicable, \$55 is charged for each additional director / owner. The Police Review Fees are set by the Calgary Police Service and are listed on this schedule for convenience only.

Note 7: Refunds: the policy on refunds is as follows. Where an applicant wishes to cancel an application listed on this schedule: cancellation request must be made within 30 days of the original payment. If the fire inspection or police check has been completed, their portion of the total fee will not be refunded. For licence renewals, if the fees are paid prior to the expiry date and the business is not operating past the expiry date, the full refund will be given.
