# Calgary A Preliminary Linear Water/Wastewater Rate Comparison

Changes include:

- Moving debt terms from 25 years to 15 years beginning in 2024
- Reduce borrowing costs
- Align pace of growth and capacity utilization

# Calgary 🔯 Updates – Established Area Linear Levy

- The City teams appreciates and has considered all feedback received from this working group
- Proactive investments, life cycle and maintenance investments are underway
- The reactive investment program will move forward as a three-year pilot program using City funding sources, no developer contributions are required.
- Evaluation at the end of the pilot and determine next steps
- Target date of implementation: First half of 2024

# Calgary 🕸 Updates – Established Area Linear Levy

Two changes compared to the proposal sent to the working group in July 2021.

- Previously proposed reimbursement of \$300,000 per project per year will be changed to a maximum reimbursement amount of \$300,000 per project.
- 2. The City will consider delivering any triggered upgrades on a project-by-project basis, depending on City resources available.



- Finalize project costs, model inputs & rates for September
- Decision on stormwater catchment vs. citywide
