Only those submissions **received** by the City Clerk **not later than 12:00 p.m.**, **MONDAY, 2021 June 14**, shall be included in the Agenda of Council. ## **CHARTER BYLAW**

Calgary City Council will consider the following proposed bylaw:

### ONLINE ADVERTISING OF PUBLIC WORKS NOTICES AND TAX RECOVERY SALES CHARTER BYLAW BYLAW 1H2021

This bylaw modifies the advertising requirements set out in sections 421(1), 436.12(1) and 534(2) of the Municipal Government Act (MGA) by replacing newspaper advertising with online advertising on The City's website, pursuant to section 606.2 of the MGA and section 4(28.1) of *The City of Calgary Charter, 2018 Regulation.* It applies to public works notices under section 534 of the MGA, and to public auctions to recover taxes (for land and for designated manufactured homes).

Pursuant to Section 231 of the MGA, a citizen may submit a petition for a vote of the electors to determine whether a proposed bylaw should be passed. The process for submitting such a petition is set out in Sections 221 to 226 of the MGA.


# LAND USE REDESIGNATION

#### 1. HIGHLAND PARK BYLAW 87D2021

To redesignate the land located at 240 – 32 Avenue NE (Plan 5942AD, Block 4, Lots 1 and 2) from Residential – Contextual One / Two Dwelling (R-C2) District **to** Residential – Grade-Oriented Infill (R-CG) District.

It should be noted that such additional material will require the approval of the Mayor before distribution to Members of Council. If the Public Hearing is still in progress at 9:30 p.m., Council may conclude the matter under discussion and will reconvene at 1:00 p.m. of the next business day, unless otherwise directed by Council.

#### 2. RESIDUAL SUB-AREA 03W BYLAW 91D2021

To redesignate the land located at 16795 Centre Street NW (Portion of N1/2 Subdivision 8 of SE1/4 Section 9-26-1-5) from Special Purpose – Future Urban Development (S-FUD) District **to** Direct Control District to accommodate additional uses including Place of Worship and Child Care Service.

### 3. RESIDUAL SUB-AREA 5D

BYLAW 90D2021

To redesignate the land located at 14119 – 52 Street NE (Portion of Plan 1440LK, Block D) from Special Purpose – Future Urban Development (S-FUD) District **to** Industrial – Outdoor (I-O) District and Special Purpose – Urban Nature (S-UN) District.

#### 4. EAST SHEPPARD INDUSTRIAL BYLAW 89D2021

To redesignate the land located at 12525 and 12655 – 52 Street SE (E1/2 Section 10-23-29-4) from Special Purpose – Future Urban Development (S-FUD) District **to** Direct Control District to accommodate a Power Generation Facility – Large.

#### 5. SPRINGBANK HILL BYLAW 88D2021

To redesignate the land located at 55 Elmont Drive SW (Plan 2011073, Block 4, Lot 17) from Direct Control District **to** Residential – One Dwelling (R-1) District.
