 - ✓ Sustainable Building Policy
 - ✓ Calgary Climate Strategy
 - ✓ <u>Design Guidelines for City of Calgary Funded Buildings</u>
 - ✓ Planning and Development Policies and Plans




Acknowledgement of Feedback Not Incorporated

- Grants:
 - No assumptions on grants embedded within the offsite levy rate formula
 - Future grants:
 - ✓ Grants from the Federal or Provincial Governments are considered City of Calgary funding
 - ✓ Exceptions considered on a case-by-case basis
- Keeping the same levy cost structure for residential and industrial lands
