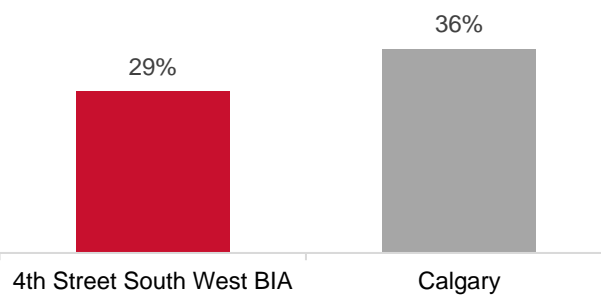

### Visible minority (Racialized population)

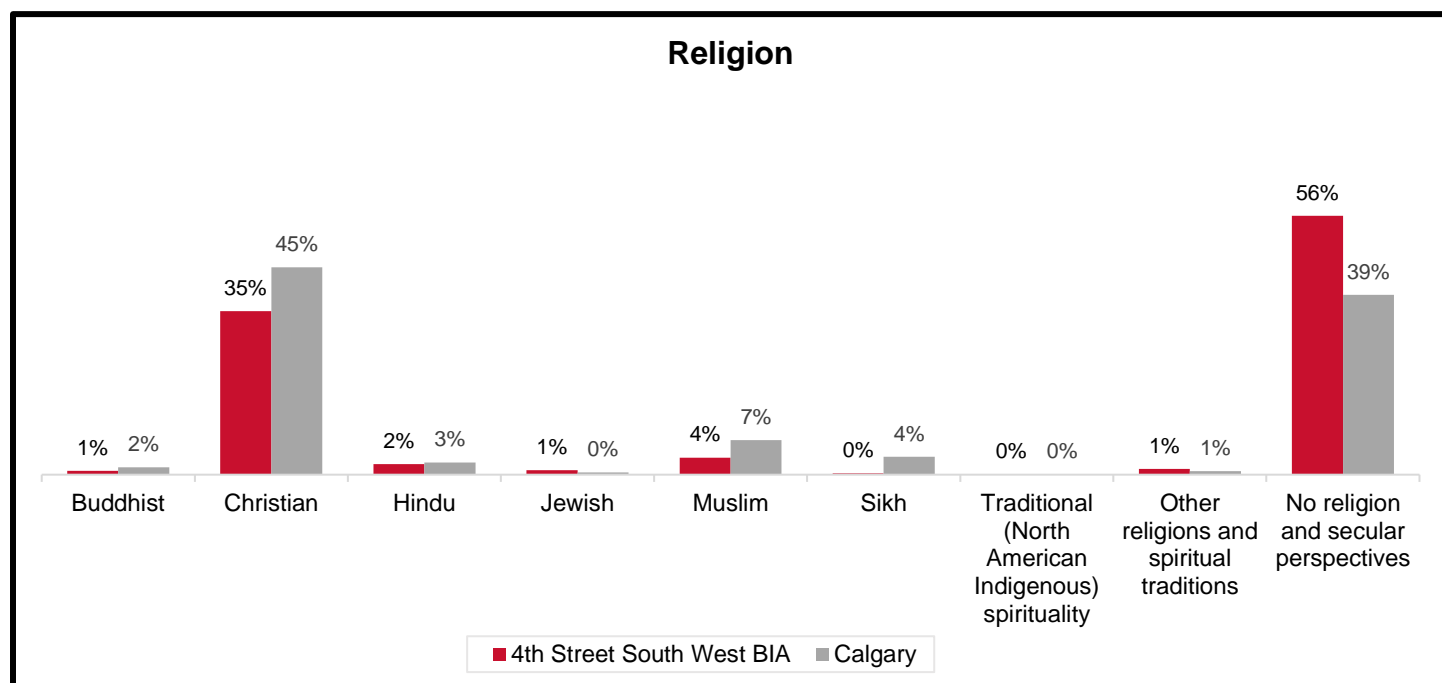

## Glossary

The definitions in this glossary are adapted from the 2021 Statistics Canada Census Dictionary ([98-301-X](#)).

### ***Adjusted after-tax income***

Refers to after-tax income of the statistical unit that is adjusted for economies of scale. The adjustment factor, also known as the equivalence scale, is the square root of the number of persons in the statistical unit. The adjusted after-tax income is calculated by dividing the after-tax income by this adjustment factor. The adjustment made to income addresses the fact that individuals living together can share resources and the marginal increase in need decreases as the number of individuals sharing resources increases.

For the 2021 Census, the reference period for income data is the 2020 calendar year, unless otherwise specified.

### ***Admission category***

Refers to the name of the immigration program or group of programs under which an immigrant has been granted for the first time the right to live in Canada permanently by immigration authorities.

- **Economic immigrant** includes immigrants who have been selected for their ability to contribute to Canada's economy through their ability to meet labour market needs, to own and manage or to build a business, to make a substantial investment, to create their own employment or to meet specific provincial or territorial labour market needs.
- **Immigrant sponsored by family** includes immigrants who were sponsored by a Canadian citizen or permanent resident and were granted permanent resident status on the basis of their relationship either as the spouse, partner, parent, grand-parent, child or other relative of this sponsor. The terms "family class" or "family reunification" are sometimes used to refer to this category.
- **Refugee** includes immigrants who were granted permanent resident status on the basis of a well-founded fear of returning to their home country. This category includes persons who had a well-founded fear of persecution for reasons of race, religion, nationality, membership in particular social group or for political opinion (Geneva Convention refugees) as well as persons who had been seriously and personally affected by civil war or armed conflict or have suffered a massive violation of human rights. Some refugees were in Canada when they applied for refugee protection for themselves and their family members (either with them in Canada or abroad). Others were abroad and were referred for resettlement to Canada by the United Nations Refugee Agency, another designated referral organization or private sponsors.
- **Other immigrant** includes immigrants who were granted permanent resident status under a program that does not fall under the economic immigrants, the immigrants sponsored by family or the refugee categories.

### ***Age***

Refers to the age of a person (or subject) of interest at last birthday (or relative to a specified, well-defined reference date).

### ***Business Improvement Area (BIA)***

Refers to a group of businesses within a defined geographic area. BIAs operate as non-profit organizations and are established for one or more of the following purposes: improving, beautifying, and maintaining property in the BIA; developing, improving, and maintaining public parking; and promoting the BIA as a business or shopping area. Businesses that are part of a BIA are subject to paying a BIA tax levy.

The data in this profile is from the 2021 Census of Canada and it reflects the Business Improvement Area boundaries as of 2022.

### ***Calgary***

Refers to the Calgary census subdivision (CSD), as defined by Statistics Canada. Equivalent to the Calgary city limit.

<b>Census family</b>	<p>Refers to a married couple and the children, if any, of either and/or both spouses; a couple living common law and the children, if any, of either and/or both partners; or a parent of any marital status in a one-parent family with at least one child living in the same dwelling and that child or those children. All members of a particular census family live in the same dwelling.</p> <ul style="list-style-type: none"> <li>• <b>Children</b> may be biological or adopted children regardless of their age or marital status as long as they live in the dwelling and do not have their own married spouse, common-law partner or child living in the dwelling. Grandchildren living with their grandparent(s) but with no parents present also constitute a census family.</li> </ul>
<b>Census reference day</b>	<p>The date to which respondents refer when answering the questions. The 2021 Census reference day was May 11, 2021.</p>
<b>Citizenship</b>	<p>Refers to the country where the person has citizenship. A person may have more than one citizenship. A person may be stateless, that is, they may have no citizenship. Citizenship can be by birth or naturalization.</p> <ul style="list-style-type: none"> <li>• <b>Canadian citizen</b> includes persons who are citizens of Canada only and persons who are citizens of Canada and at least one other country.</li> <li>• <b>Not a Canadian citizen</b> refers to persons who are not citizens of Canada. They may be citizens of one or more other countries. Persons who are stateless are included in this category.</li> </ul>
<b>Community</b>	<p>Refers to the Calgary Community District boundaries. Community boundaries delineate where a specific community physically begins or ends within Calgary. For the 2021 Census of Canada, community boundaries from 2021 were used. A full list of communities and their boundaries can be found on the <a href="#">Calgary Open Data Catalogue</a>.</p>
<b>Dwelling</b>	<p>Refers to a set of living quarters.</p> <ul style="list-style-type: none"> <li>• <b>Collective dwelling</b> refers to a dwelling of a commercial, institutional, or communal nature in which a person or group of persons reside or could reside. It must provide care or services or have certain common facilities, such as a kitchen or bathroom, which are shared by the occupants. Examples include lodging or rooming houses, hotels, motels, tourist establishments, nursing homes, residences for senior citizens, hospitals, staff residences, military bases, work camps, correctional facilities and group homes.</li> <li>• <b>Private dwelling</b> refers to a separate set of living quarters with a private entrance either from outside the building or from a common hall, lobby, vestibule, or stairway inside the building. The entrance to the dwelling must be one that can be used without passing through the living quarters of some other person or group of persons.</li> </ul>
<b>Dwelling condition</b>	<p>Refers to the dwelling's need of repairs. This does not include desirable remodelling or additions.</p> <ul style="list-style-type: none"> <li>• <b>Regular maintenance needed</b> includes dwellings where only regular maintenance such as painting, or furnace cleaning is needed.</li> <li>• <b>Minor repairs needed</b> includes dwellings needing only minor repairs such as dwellings with missing or loose floor tiles, bricks or shingles or defective steps, railing or siding.</li> <li>• <b>Major repairs needed</b> includes dwellings needing major repairs such as dwellings with defective plumbing or electrical wiring and dwellings needing structural repairs to walls, floors, or ceilings.</li> </ul>

**Dwelling  
structure type**

Refers to a set of living quarters in which a person or a group of persons reside or could reside.

Structure types include:

- **Single-detached house:** A single dwelling not attached to any other dwelling or structure (except its own garage or shed). A single-detached house has open space on all sides, and no dwellings either above it or below it.
- **Semi-detached house:** One of two dwellings attached side by side (or back-to-back) to each other, but not attached to any other dwelling or structure (except its own garage or shed). A semi-detached dwelling has no dwellings either above or below it, and the two units have open space on all sides.
- **Apartment or flat in a duplex:** One of two dwellings located one above the other. Duplexes could be attached to triplexes, other duplexes, or other non-residential structures (e.g., a store).
- **Row house:** One of three or more dwellings joined side by side (or occasionally side to back), such as a townhouse or garden home, but not having any other dwellings either above or below.
- **Apartment, less than five storeys:** A dwelling unit attached to other dwelling units, commercial units or other non-residential space in a building that has fewer than five storeys.
- **Apartment, five or more storeys:** A dwelling unit in a high-rise apartment building that has five or more storeys. Also included are apartments in a building with five or more storeys where the first floor or second floor is commercial establishments.
- **Other single-attached house:** A single dwelling that is attached to another building and that does not fall into any of the other categories, such as a single dwelling attached to a non-residential structure (e.g., a store or church) or occasionally to another residential structure (e.g., an apartment building).
- **Other dwelling:** A single dwelling designed and constructed to be transported on its own chassis and capable of being moved to a new location on short notice. It may be placed temporarily on a foundation such as blocks, posts or a prepared pad and may be covered by a skirt.

**Employment  
status**

Refers to the employment status of a person during the period of Sunday, May 2 to Saturday, May 8, 2021.

- **Employed:** A person who did any work at all at a job or business, that is, paid work in the context of an employer-employee relationship, or self-employment. This also includes persons who did unpaid family work, which is defined as unpaid work contributing directly to the operation of a farm, business or professional practice owned and operated by a related member of the same household. Also includes those who had a job but were not at work due to factors such as their own illness or disability, personal or family responsibilities, vacation or a labour dispute. This category excludes persons not at work because they were on layoff or between casual jobs, and those who did not then have a job (even if they had a job to start at a future date).
- **Unemployed:** A person who was without paid work or without self-employment work and was available for work. An unemployed person either: had actively looked for paid work in the past four weeks; was on temporary lay-off and expected to return to his or her job; or had definite arrangements to start a new job in four weeks or less.
- Previously, in other census cycles, early enumeration was conducted in remote, isolated parts of the provinces and territories in the months leading up to the May enumeration. Due to COVID-19, there was no early enumeration for the 2021 Census. Collection procedures—especially in collective dwellings and remote, northern, First Nations, Inuit and Métis communities—were redesigned to ensure the census was conducted in the best possible way, using a safe and secure approach.

<b>Employment rate</b>	Refers to the number of persons employed in the week of Sunday, May 2 to Saturday, May 8, 2021, expressed as a percentage of the total population aged 15 years and over.
<b>Generation status</b>	<p>Refers to whether or not a person's parents were born in Canada.</p> <ul style="list-style-type: none"> <li>• <b>First generation</b> refers to a person who was born outside Canada. For the most part, these are people who are now, or once were, immigrants to Canada.</li> <li>• <b>Second generation</b> refers to a person who was born in Canada with at least one parent born outside Canada. For the most part, these are the children of immigrants.</li> <li>• <b>Third generation or more</b> refers to a person who was born in Canada with both parents born in Canada.</li> </ul>
<b>Gender</b>	<p>Refers to an individual's personal and social identity as a man, woman, or non-binary person (a person who is not exclusively a man or a woman).</p> <p>A person's gender may differ from their sex at birth, and from what is indicated on their current identification or legal documents such as their birth certificate, passport, or driver's licence. A person's gender may change over time.</p> <p>Statistics Canada collected data about transgender and non-binary populations for the first time on the 2021 Census. The category "Men+" includes men (and/or boys), as well as some non-binary persons. The category "Women+" also includes women (and/or girls), as well as some non-binary persons.</p>
<b>Highest certificate, diploma or degree completed</b>	<p>Refers to the highest level of education that a person has successfully completed and is derived from the educational qualifications questions, which asked for all certificates, diplomas, and degrees to be reported.</p> <p>CEGEP is an acronym from the French term Collège d'enseignement general et professionnel, which means General and professional teaching college. In Quebec, it's a public school that provides the first level of post-secondary education.</p>
<b>Household</b>	Refers to a person or group of persons who occupy the same dwelling and do not have a usual place of residence elsewhere in Canada or abroad. The dwelling may be either a collective dwelling or a private dwelling. The household may consist of a family group such as a census family, of two or more families sharing a dwelling, of a group of unrelated persons or of a person living alone. Household members who are temporarily absent on reference day are considered part of their usual household.
<b>Household income</b>	Refers to the sum of the total income of all household members during 2020.
<b>Household size</b>	Refers to the number of persons in a private household.
<b>Housing affordability (shelter-cost-to-income ratio)</b>	Refers to the proportion of average total household income which is spent on shelter costs. Shelter costs for owner households include, where applicable, mortgage payments, property taxes and condominium fees, along with the costs of electricity, heat, water, and other municipal services. For renter households, shelter costs include, where applicable, the rent and the costs of electricity, heat, water, and other municipal services.
<b>Housing suitability</b>	Refers to whether a dwelling has enough bedrooms for the size and composition of the household (taking into consideration age, sex, and relationship among household members) based on the National Occupancy Standard (NOS) that was developed by Canada Mortgage and Housing Corporation. A household is deemed to be living in suitable accommodation if its dwelling has enough bedrooms, as calculated using the NOS.

<b>Housing tenure</b>	<p>Refers to whether a household rents or owns their private dwelling.</p> <ul style="list-style-type: none"> <li>• <b>Owner</b> refers to a household where some member of the household owns their dwelling, even if it is still being paid for.</li> <li>• <b>Renter</b> refers to a household where no member of the household owns their dwelling. The dwelling is considered to be rented even if no cash rent is paid.</li> </ul>
<b>Immigrant status</b>	<ul style="list-style-type: none"> <li>• <b>Immigrant</b> refers to persons who are, or who have ever been, landed immigrants or permanent residents. Such persons have been granted the right to live in Canada permanently by immigration authorities. Immigrants who have obtained Canadian citizenship by naturalization are included in this category.</li> <li>• <b>Recent immigrant</b> refers to persons who are immigrants who landed in Canada between January 1, 2016 and May 11, 2021.</li> <li>• <b>Non-immigrant</b> refers to persons who are Canadian citizens by birth.</li> <li>• <b>Non-permanent resident</b> refers to persons from another country with a usual place of residence in Canada and who have a work or study permit or who have claimed refugee status (asylum claimants).</li> <li>• <b>Year of immigration</b> refers to the year in which the immigrant first obtained their landed immigrant or permanent resident status.</li> </ul>
<b>Income Inequality</b>	<p>One measure of income inequality is the P90/P10 ratio. It is the ratio of the 90<sup>th</sup> and the 10<sup>th</sup> percentile of the adjusted household after-tax income. The 90<sup>th</sup> percentile means 90% of the population has income that falls below this threshold. The 10<sup>th</sup> percentile means 10% of the population has income that falls below this threshold.</p>
<b>Income reference year</b>	<p>Refers to the year to which respondents refer when answering income-related questions. The census income reference year is the calendar year prior to the <b>census reference day</b>. For the 2021 Census, the income reference year was January 1 to December 31, 2020.</p>
<b>Indigenous identity</b>	<p>Refers to whether the person identified with the Indigenous peoples of Canada. This includes those who identify as First Nations (North American Indian), Métis and/or Inuk (Inuit), and/or those who report being Registered or Treaty Indians (that is, registered under the Indian Act of Canada), and/or those who have membership in a First Nation or Indian band. Aboriginal peoples of Canada (referred to here as Indigenous peoples) are defined in the Constitution Act, 1982, Section 35 (2) as including the Indian, Inuit and Métis peoples of Canada.</p>
<b>Industry</b>	<p>Refers to the general nature of the business carried out in the establishment where the person worked. The industry data are produced according to the North American Industry Classification System (NAICS).</p>
<b>Knowledge of non-official languages</b>	<p>Refers to whether the person can conduct a conversation in a language other than English or French. For a child who has not yet learned to speak, this includes languages that the child is learning to speak at home. The number of languages that can be reported may vary between Census surveys, depending on the objectives of the survey.</p>
<b>Knowledge of official languages</b>	<p>Refers to whether the person can conduct a conversation in English only, French only, in both or in neither language. For a child who has not yet learned to speak, this includes languages that the child is learning to speak at home.</p>
<b>Labour force participation rate</b>	<p>Refers to the total <b>labour force</b> in that group, expressed as a percentage of the total population in that group.</p>



<b>Labour force status</b>	<p>Refers to whether a person was employed, unemployed or not in the labour force during the reference period.</p> <ul style="list-style-type: none"> <li>• <b>In the labour force</b> refers to persons who during the reference period were either employed or unemployed. The labour force consists of persons who contribute or are available to contribute to the production of goods and services falling within the System of National Accounts production boundary.</li> <li>• <b>Not in the labour force</b> refers to persons who were neither employed nor unemployed during the reference period. This includes persons who, during the reference period were either unable to work or unavailable for work. It also includes persons who were without work and who had neither actively looked for work in the past four weeks nor had a job to start within four weeks of the reference period.</li> </ul>
<b>Language spoken most often at home</b>	Refers to the language spoken most often at home by the individual. A person can report more than one language as “spoken most often at home” if the languages are spoken equally often. For a person who lives alone, the language spoken most often at home is the language in which he or she feels most comfortable. For a child who has not yet learned to speak, this is the language spoken most often to the child at home.
<b>Low income measure after-tax (LIM-AT)</b>	Refers to a <b>dollar threshold</b> that defines low income as half of the median <b>adjusted after-tax income</b> of Canadian households, where “adjusted” indicates that the number of people in a household is taken into account. Persons whose income falls below this amount are considered to be in low income based on LIM-AT. For reference, the LIM-AT threshold for a 1-person household in 2020 was \$26,503.
<b>Low-income status</b>	Refers to the position of a person in relation to the <b>low income measure after-tax (LIM-AT)</b> during the <b>income reference year</b> . Members of a household all share the same income status.
<b>Marital status</b>	<p>Refers to whether or not a person is living in a common-law union as well as the legal marital status of those who are not living in a common-law union. All persons aged less than 15 are considered as never married and not living common law. Possible marital statuses are:</p> <ul style="list-style-type: none"> <li>• <b>Common-law:</b> Refers to a person who is living with another person as a couple but who is not legally married to that person. Includes persons living with same and opposite sex partners.</li> <li>• <b>Divorced:</b> Refers to a person who has obtained a legal divorce and who has not remarried and are not living with a person as a couple. Persons living common-law are not included in this category.</li> <li>• <b>Married:</b> Refers to a person who is legally married and who has not separated or obtained a divorce, and whose spouse is living. Includes persons married to same and opposite sex spouses.</li> <li>• <b>Separated:</b> Refers to a person who is married but who no longer lives with his/her spouse (for any reason other than illness, work or school) and who has not obtained a divorce. Persons living common-law are not included in this category.</li> <li>• <b>Single:</b> A person who has never married or a person whose marriage has been annulled and who has not remarried. Persons living common-law are not included in this category.</li> <li>• <b>Widowed:</b> A person who has lost his/her spouse through death and who has not remarried and are not living with a person as a couple. Persons living common-law are not included in this category.</li> </ul>
<b>Median income</b>	Refers to the middle dollar value where half of the population earns more, and half of the population earns less.

<b>Mobility status</b>	<p>Several terms refer to whether a person lived in the same residence on the <a href="#">census reference day</a> as they did on the same date one or five years earlier.</p> <ul style="list-style-type: none"> <li>• <b>Non-mover:</b> Refers to a person who has not moved to a new residence.</li> <li>• <b>Mover:</b> Refers to a person who has moved from one residence to another.</li> <li>• <b>Non-migrant:</b> Refers to a person who did move but remained in <a href="#">Calgary</a>.</li> <li>• <b>Migrant:</b> Refers to a person who moved to Calgary from a different city, town, village, or Indian reserve.</li> <li>• <b>Internal migrant:</b> Refers to a person who moved to Calgary from a different city, town, village, or Indian reserve within Canada.</li> <li>• <b>External migrant:</b> Refers to a person who moved to Calgary from a different country.</li> </ul>
<b>Mode of transportation to work</b>	Refers to the main mode of transportation a person uses to travel between their home and their place of work. Persons who used more than one mode of transportation were asked to identify the single mode they used for most of the travel distance. The question does not measure multiple modes of transportation, nor does it measure the seasonal variation in mode of transportation or trips made for purposes other than the commute from home to work.
<b>Mother tongue (First language learned at home)</b>	Refers to the first language learned at home in childhood and still understood by the person at the time the data was collected. If the person no longer understands the first language learned, the mother tongue is the second language learned. For a person who learned more than one language at the same time in early childhood, the mother tongue is the language this person spoke most often at home before starting school. The person has more than one mother tongue only if they learned these languages at the same time, and still understands them. For a child who has not yet learned to speak, the mother tongue is the language spoken most often to this child at home. A child who has not yet learned to speak has more than one mother tongue only if these languages are spoken to them equally often so that the child learns these languages at the same time.
<b>Occupation</b>	Refers to the kind of work performed in a job, a job being all the tasks carried out by a particular worker to complete their duties. An occupation is a set of jobs that are sufficiently similar in work performed. The occupation data are produced according to the National Occupational Classification [NOC] 2021.
<b>One-parent</b>	Refers to mothers or fathers, with no married spouse or common-law partner present, living in a dwelling with one or more children.
<b>Place of birth</b>	Refers to the name of the geographic location where the person was born. The geographic location is specified according to boundaries current at the time the data are collected, not the boundaries at the time of birth. For a breakdown of the countries included in each continent, please refer to the <a href="#">Countries and Areas of Interest for Social Statistics – SCCAI 2019</a> .
<b>Population in private households</b>	<p>Refers to all persons or group of persons who occupy the same dwelling and do not have a usual place of residence elsewhere in Canada or abroad. For census purposes, households are classified into three groups: private households, collective households, and households outside Canada. Unless otherwise specified, all data in census products are for private households only.</p> <p>Includes Canadian citizens and landed immigrants whose usual place of residence is Canada. Also includes refugee claimants, holders of work and study permits, Canadian citizens and landed immigrants at sea or in port aboard merchant or government vessels, and Canadian citizens away from Canada on military or diplomatic business. Excludes government representatives and military members of other countries and residents of other countries visiting Canada.</p>

<b>Religion</b>	<p>Refers to a person's self-identification as having a connection or affiliation with any religious denomination, group, body, or other religiously defined community or system of belief. Religion is not limited to formal membership in a religious organization or group.</p> <p>For infants or children, religion refers to the specific religious group or denomination in which they are being raised, if any.</p> <p>Persons without a religious connection or affiliation can self-identify as atheist, agnostic or humanist, or can provide another applicable response.</p>
<b>Total income</b>	<p>Refers to sum of income of a regular and recurring nature, including employment income, pension income, investment income, income from government programs, other regular cash income list child support or spousal support payments received during the <b>income reference year</b>. Excludes one-time receipts such as lottery winnings, cash inheritances, lump-sum insurance settlements, tax-free savings account and registered retirements savings plan withdrawals, and capital gains.</p> <p>In the context of individuals, it is calculated for those with income from certain sources, before income taxes and deductions, during a specified reference period.</p>
<b>Visible minority (Racialized population)</b>	<p>Refers to persons, other than Indigenous peoples, who are non-Caucasian in race or non-white in colour.</p> <p>In 2021 Census products, the term "visible minority" has been replaced by the terms "racialized population" or "racialized groups", reflecting the increased use of these terms in the public sphere.</p>
<b>Ward</b>	<p>Refers to the Calgary ward boundaries. Wards are specific local regions within Calgary that are comprised of multiple communities. The boundaries of Calgary's wards are reviewed and revised every four years as Calgary grows. Hence, comparisons should not be drawn between wards over time. For the 2021 Census of Canada, ward boundaries from 2021 were used.</p>
