Livery Inspection Stations and their Certified Livery Mechanics are governed by Livery Transport Bylaw 20M2021 and defined as:

"Livery Inspection Station means premises and equipment and other resources required to complete an E.L.V.I.S. inspection that have been certified by the Chief Livery Inspector for the purpose of conducting mechanical inspections of Livery Vehicles"

"Certified Mechanic means a person who holds a valid and subsisting Certificate of Proficiency as a journeyman motor mechanic or heavy duty mechanic issued by the Province of Alberta and where required by the Director holds additional certificates of qualifications as deemed necessary and is approved by the Director to issue Inspection Certificates"

Failure of the Inspection Station and/or its Certified Livery Mechanic to comply with this Bylaw may result in revocation and/or suspension of privileges to operate as a Livery Inspection Station.
