



Inglewood/ Ramsay City Projects Update – January 2021

Green Line LRT – Project Update

As we move into 2021, the Green Line project team is progressing key priorities following the direction of Council in June 2020. The City continues to work with the Province to support the provincial review of the Green Line LRT project. In order to provide the time needed to conclude these discussions, a decision was made in December 2020 to pause the procurement for segment 1. This pause does not impact the work that is currently underway including progressing enabling works to make way for segment 1 construction and functional planning for segment 2 (16 Avenue North to Inglewood/Ramsay).

Green Line continues to advance planning and design for segment 2 (Elbow River to 16 Avenue North) with the next phase of virtual engagement starting in late January to inform planning for segment 2 project areas, including the:

- Streetscape Masterplan for Centre Street North
- North Central Mobility Study
- North Central Bus Rapid Transit (BRT) Study
- Bow River Bridge

As part of Green Line's Business Support Program (BSP), the project team is establishing a Business Insights Panel (BIP) to provide insights from the local business community which will inform the purpose and structure of the BSP. Members of the BIP were invited to a meet and greet on January 12, with regular monthly meetings that started on January 26, 2021.

North Central Mobility and North Central BRT Studies – Engagement opportunities

The City is conducting two studies to identify improvements to the Bus Rapid Transit (BRT) service along Centre Street and Harvest Hills Boulevard to understand the influence of these changes and the addition of Green Line LRT on the transportation network in north central Calgary.

North Central Mobility Study

A mobility study reviews the safety, connectivity and efficiency of the transportation network. The results of the study will help to identify issues and challenges with the transportation network, and develop measures to enable the network to accommodate the continued growth of Calgary.

During the first phase of engagement for the North Central Mobility Study, the project team heard feedback on how Calgarians in the study area travel through their neighborhoods and connect to important destinations. This feedback and technical analyses of future traffic growth projections was used to develop ideas for improving future traffic conditions. During this phase of engagement, we are sharing our findings of how travel patterns may change in the future when the new LRT and BRT services are open, and we would like your feedback on how to improve the transportation network to support the services.

North Central BRT Study

As part of engagement for the North Central BRT Study, the project team heard feedback about issues and opportunities to improve how BRT stations function in your neighbourhoods and how we can improve the corridor and transit service in general. This feedback was used to develop concepts for improvements to the existing BRT route from downtown to 160

Avenue N. During this phase of engagement we will be asking for feedback on these concepts and to help prioritize improvements.

Guidebook for Great Communities

We are excited to announce that the newly **updated Guidebook for Great Communities** is now online.

In response to Council direction from July 2020, we've updated a number of areas:

- Simplified the Urban Form Categories (UFC) in Chapter 2
- Moved policies from Chapter 3 to the appropriate UFC section in Chapter 2, so they are in the same place.
- Expanded policies that help preserve Heritage assets
- Added direction to incorporate climate change policy in alignment with Calgary's Climate Resilience Strategy
- Added policy on Low Density Residential to ensure density is in the right place
- Simplified the language so it's easier to read and gives clearer direction
