4 Aspects of Climate Equity

"Climate equity means working towards the just distribution of the benefits of climate actions (mitigation and adaptation) and alleviating unequal burdens created or worsened by climate change."

- Procedural (Inclusion)
- Distributional (Access)
- > Structural
- > Transgenerational




Do our Climate Actions disproportionately impact anyone, and how can we address that?

Climate risk is inequitably distributed geographically and is driven in part by social factors.

Community Climate Risk 2050






Equity and Mitigation

The Global Carbon Budget is allocated **equitably** amongst municipalities based on the following principles:

- Equality based on an understanding that human beings should have equal rights / quality of life
- Responsibility for contributing to climate change based on historic and current emissions
- Capacity to contribute to solving the problem



A **carbon budget** is the cumulative amount of carbon dioxide (CO2) emissions permitted over a period of time to keep within a certain temperature threshold (ex. 2 degrees global temperature increase).



Energy Poverty

'Energy poverty' means lack of access to affordable energy.

Calgary has areas of very highcost burden (10%+ of household income) in all quadrants, and for both renters and owners.

Energy poverty connects to climate, economic, and social outcomes.







Equality, Equity & Justice


Equality means everyone gets the same thing.




Climate Equity Principles (UNFCCC)
