



The City of Calgary Rain Barrel Rebate Program Application

How the Rebate Works

Calgarians purchasing rain barrels from Green Calgary, or a local vendor (Calgary only) can submit the following application form with original receipts for up to two rain barrels per household and receive \$50 per barrel.

Eligible purchases are those made after March 31st, 2025. This program can disburse rebates on a maximum of 3,000 barrels. Once the program is fully allocated it will be closed until further notice.

Rebate's may take 2-4 weeks from the date of application submission before it is processed and funds are sent out. Rebate's for rain barrels pre-ordered through Green Calgary's online Ecostore may take 2-4 weeks from the date of order pick-up/ fulfillment.

*In order to receive this rebate, you must have a Canadian bank.

Receipt Submission Instructions

Physical receipt submission:

Applicants must write "applied for city rebate" on their original receipts, with the items eligible for the rebate highlighted or underlined on the receipt.

Online delivery receipt submission:

Applicants must submit the two following documents:

1. Their online receipt and
2. a) A photo of their barrel packaging (address label) or mail slip matching information to the receipt or
b) A delivery confirmation from a postal service with matching information to the receipt.

Green Calgary online pre-order:

Attach the invoice you were emailed after completing your purchase.

The City of Calgary and Green Calgary have teamed up to provide all Calgarians with an opportunity to receive a \$50 rebate/per barrel on up to two rain barrels starting April 1st, 2025.

Eligibility

All of the following must be applicable to determine eligibility.

- You've purchased your rain barrel(s) from Green Calgary, or a local vendor (Calgary only) or
 - If you are ordering your rain barrel(s) online, the vendor you chose has a physical storefront located in Calgary.
- You are a Calgary home owner, tenant, or resident.
- Your rain barrels are intended for your Calgary residence.
- You are applying for this rebate as an individual, and not on behalf of a business.
- You have a Canadian bank.
